

TOWN OF BRADFORD
APPLICATION FOR WETLANDS CONDITIONAL USE PERMIT

A Conditional Use Permit may be granted by the Planning Board (RSA 674:21 II) for the construction of roads and other access ways, and for pipelines, power lines, and other transmission lines provided that all of the following conditions are met:

- A. The proposed construction is essential to the productive use of the land not part of the Wetland Areas.
- B. Design, construction and maintenance methods will be such as to minimize detrimental impact upon the wetland and will include restoration of the site as nearly as possible to its original grade and conditions.
- C. No alternative route which does not cross a wetland or which has less detrimental impact on the wetland is feasible.
- D. Cost of the proposed construction compared to alternatives shall not be considered in granting or denying a permit.
- E. The Conservation Commission has had the opportunity to review and comment.

- c. Labeling of each proposed impact area with the square footage.
- d. Proposed methods of erosion or siltation controls.
- e. Location of existing and proposed structures.
- f. Location of existing and proposed stormwater and erosion control measures and structures.
- g. Existing and proposed topography at two-foot intervals.
- h. Extent of tree/vegetation cutting and clearing.

C. Project description (please attach a written description which addresses the following three items. Length should not exceed two pages.):

1. Describe the proposed activity and how it is essential to the productive use of the land not part of the Wetland Areas.
2. Describe the impact to wetlands, surface waters, and buffer zones, and how design construction and maintenance methods will be such as to minimize detrimental impact upon the wetlands and will include restoration of the site as nearly as possible to its original grade and conditions.
3. Explain how no alternative route (one which does not cross a wetland or which has less detrimental impact on the wetland) is feasible.
